A friend who waits at midnight hour, with a soft velvet muzzle, a nicker and patient eyes for the kind of woman I will be When I am old. ♥





EMIGRANT TRAIL CONSERVANCY UPDATE A BIT OF HISTORY

Although the many of public trails in Nevada County are above Nevada City, there is a vital need for trails in the southern part of the County where the majority of the population resides. To meet this need and as mitigation, when three rural subdivisions that contained the oldest portion (est. 1844) of the historic Emigrant Trail came up for approval in the 1970s, the Board of Supervisors required the developers to survey, provide easements with right of way, and open to the public six miles of public trail through those easements.

Over the years, the trail easements have been contentious. Some landowners who have the trail easement on their deeds have ignored the provision, building fences, an arena and buildings on the public easement. Some have threatened those who have tried to walk the trail. The County did nothing to stop the encroachments or enforce the public's right to the trail easement.



COUNTY RESOLUTION TO SUSPEND PUBLIC ACCESS

The Emigrant Trail Conservancy was established to regain the public's rights to their trail and asked the Board to consider the issue. On November 8, 2011, by Resolution 11-521, the Nevada County Board of Supervisors suspended public access to the six miles of public trail easements for the Emigrant Trail from Dog Bar to Highway 49 for 18 months. They continue to be open to those who live within the Golden Oaks, Sunshine Valley and Lodestar II subdivisions. The Board said the closure was needed for public safety and to give time for the Board to come to conclusion on the future of the easements.

On January 12, 2012, the Planning Department provided the Board with research, a proposed schedule and milestones for addressing the public trail easements.

The timeline included meeting with the subdivisions' representatives and the general public to try to obtain some consensus, providing public tours of the trail, conducting a public opinion survey, physically walking and finding the original survey markers to re-establish the route, and to provide the Board with regular updates as well as with their recommendations and options.

The public closure was to sunset May 2013, unless the Board extended the suspension.

PLANNING DEPARTMENT RESEARCH AND OPTIONS

On August 28, 2012, the Planning Department presented their research to the Board, including results of the one June Workshop, identified issues, and Staff identified options.

The Staff options, which will be considered by the Board are:

- 1. Maintain the existing trail easements for future development of a public trail by a recreation provider.
- 2. Remove "Suspension of Use" and allow the public use of the trail easements in their existing condition.
- 3. Maintain the existing trail easements for future development of a PRIVATE trail.
- 4. Relocate the trail easements within the subdivisions.
- 5. Relocate the easements outside the subdivisions.
- 6. Continue suspension of use.
- 7. Abandon the public use component of the trail easements and maintain a historic preservation component.
- 8. Abandon all rights to the easement, including termination of public right.

EMIGRANT TRAIL CONSERVANCY HIRES LEGAL COUNSEL

Since several of the Staff recommended options included abandonment or elimination of the public right of way, the Emigrant Trail Conservancy hired Shute, Mihaly & Weinberger from San Francisco to legally research if the Board can abandon or restrict public rights to the trail. A letter requesting records was sent to the Board in November 2012. The collection of those records have been completed and a letter to the Board with legal conclusions is currently being prepared and will be sent this month.

Because the Conservancy found it necessary to hire legal representation, it has incurred some costs. It has successfully applied for its 501(c) (3) status so that the Conservancy may provide a tax deduction for those who wish to donate to this cause.

Once the legal issues have been resolved and the trail is reopened, GCTC has offered by letter to the County its expertise in management for this trail.

CONCLUSION

If anyone in GCTC would like a copy of the Board of Supervisors' Emigrant Trail packet, including the Planning Department's schedule, milestones, research and options, I will be glad to send it electronically to their email address. It is a 3.2MG file of 31 pages. I will also send to those who wish it, the letter from Shute, Mihaly & Weinberger that will be given to the Board this month.

The historic Emigrant Trail belongs to us, the public. The subdivision's landowners have never owned these easements and purchased properties with the public easements clearly detailed on the deeds. When the County does the right thing and re-opens the trail to the public, the historic Emigrant Trail will be a lovely hiking/equestrian path through the digger pines and oak studded hills of south County. The trail will increase the value of all properties within walking distance. The subdivisions' land owners and the public will be the beneficiaries of everything we know a trail provides.

Five Year Plan Survey Results

Here are the results of the survey for the 5 year plan. There were some ties, so some projects have the same priority. This information has been shared with the Forest Service.

Project	priority	
Trail Maintenance: Our agreement with the Forest Service is to maintain trails we build. We're on a 4 year maintenance schedule to cycle through all the trails we are responsible for.	1	
Cable Trail: This project has been in the planning stage for 3 years. We're waiting for a NEPA report from the Forest Service before we can proceed	2	
Skillman: Corrals at each campsite		
Little Lasier: Upgrade corrals and build additional corrals		
Upper Burlington staging area improvement, Possibly adding gravel		
Loney Meadows: Grade and surface from Bowman Road to the old cabin and up to the meadow used for camping		
Create a trailhead on Bowman Road: This is on PG&E land. They want a flush toilet, but would only give us a 5 year lease. If we can get an easement, it would be feasible.		
Bowman Mtn trail relocation: It is mostly complete; the trail is re-routed around meadow. Joe wants the trail re-routed around old dairy. Trail is flagged and Joe needs to look at it	8	
Loney Meadows campsite improvement: The Forest Service does have a planned area	9	
PG&E land near Bowman Lake Rd: additional trails will be developed (Bear/Yuba acquisition due to required PG&E divestiture)	9	
Skillman: Manure collection bunker	10	
Rice Crossing trail involvement: Trail will go from from Bullards Bar to South Yuba State Park (dependent on grant applied for by Bear/Yuba)		
Pack Saddle camp upgrade: Work with Forest Service	11	
Skillman bathrooms: We discussed new bathrooms for Skillman, but they would cost \$50,000 per bathroom, which doesn't seem feasible without a grant	12

Gold Country Trails Council Minutes of the Board of Directors Meeting December 11, 2012 Coldwell Banker Realty Building 855 Sutton Way Grass Valley, Ca 95945

The executive board meeting was called to order by President Helen Harvey at 7:03.

Members present included: President: Helen Harvey Secretary: Karen Schwartz Treasurer: Kathy Southgate Forest Service Liaison: Willie Brusin Board Members: Don Soto, Jeff Foltz, Vicki Testa Members: Mary Johnson (Membership Chair)

Absent: Vice President: Melissa Ribley Teri Personeni (Past President)

Helen requested approval of the November minutes. No changes were offered, and the minutes were approved.

Treasurer Kathy Southgate reported that the bank balance as of 11/30/12 was \$14, 670.76. Current membership renewals are now about 75. The \$3.00 dues increase to \$25.00 will increase income by about \$500. Membership Chair Mary Johnson inquired if there are still funds available for members who can't afford the expense, and Kathy responded that there is currently one free membership available and more memberships can be covered as necessary.

Old Business:

Forest Service Liaison Willie Brusin reviewed his report dated 12/11/2012, including the following items:

Bowman Road Parking: The snow park cannot be used for summer parking. We need to contact the Bear-Yuba Land Trust to determine if the parking area is in the portion of land, which will be eventually deeded to them.

Pioneer Trail: The NEPA report for the relocation of the Pioneer Trail section near the Washington Overlook is expected to be completed in the Spring, 2013. Another Tahoe National Forrest project is being sought by Joe Chavez in the Cable Trail area to facilitate the sharing of the cost of the Cable Trail NEPA report. The maintenance of the Pioneer Trail is shared by Bicyclists of Nevada County, which covers the part of the trail extending from 5-Mile House to Skillman Campground, and GCTC, which focuses on the trail between Skillman to Bear Valley.

Skillman Campground: Willie and Sue Brusin and Melissa and Robert Ribley met recently with Tahoe National Forest representatives to discuss various changes proposed for the campground. These include reconfiguring the 16 individual campsites to protect large trees, eliminating the \$100.00 group camp area, adding three new single pit toilets, sinking a new well to provide potable water, installing high lines rather than more corrals, improving manure control, limiting the Poker Ride to 60 trailers, and asking the California Land Management to provide an onsite host during 2013. In addition, a free day use parking area will be created outside the gate, the Upper Burlington Road log landing will be expanded to provide overflow parking, and pull outs will be created on various parts of the Hallelujah Trail and the Pioneer Trail going down to Bear Valley to facilitate two way traffic.

Board Member Don Soto suggested another Skillman sign be added for eastbound traffic.

Helen announced that she will use the nine responses received to the GCTC planning survey as indicative of the members' priorities, i.e., trail maintenance, upgrading amenities at Skillman, etc.

Helen reported that she contacted our insurance agent regarding the status of our insurance policy. She noted that we must inform our insurer of the dates of GCTC activities. Helen will pursue the question of whether board members are indemnified for errors and omissions.

Don Soto asked for an update on the status of financing the Porta-Potty at Empire Mine. Helen stated that no local businesses have offered to subsidize this expense, and the Porta-Potty will likely be removed.

New Business:

Helen asked the board if sending sympathy notes to members who have lost beloved horses should be included in the duties of the Sunshine Chair. There was consensus that this should be done in the future.

Helen reminded the board members that several positions need to be filled. She said that the Publicity Chair is still open. Regarding the need to recruit more phone tree callers, Membership Chair Mary Johnson reported that several members had expressed an interest in doing this on their membership forms.

Helen announced that Sandy Ruggiero has volunteered to take over producing the 2013 GCTC Membership Directory.

Don requested that the membership form be amended to include members' horses' breeds, so that members looking for others to ride with can better judge who might want to ride at the same pace, e.g., gaited vs. non-gaited breeds. It was agreed by consensus that although it is too late to do this for the current year, this will be done in the future. The information will be included in future membership directories.

Helen stated that a meeting place is needed for future executive board meetings. Don Soto said the Board of Realtors Office may be available and offered to look into it and report back at the next meeting.

Helen asked the board to generate a tentative 2013 calendar of GCTC activities to be presented at the January, 2013 membership meeting (see attached calendar). Willie recommended that Melissa contact California Land Management regarding coordinating GCTC work day efforts with their crew, as was done at Little Lasier last June. Board Member Vicki Testa and Sue Brusin reported that trail work is needed at various specific points on the Pioneer Trail above Skillman Campground. Helen recommended moving this higher on our priority list.

GCTC Historian Sharon Silver asked the board whether the GCTC scrapbook should continue since she has observed that members don't seem aware of or interested in it. Board members examined the scrapbook and complimented Sharon on it. In the future, members will be encouraged to check out the scrapbook during refreshment breaks during general membership meetings.

There being no other business, the meeting was adjourned at 8:31.
